

3rd Boys Lacrosse Quiz for 2016 season

Simultaneous and Dead Ball Fouls

1. A1 has possession and is held illegally by B1, flag down. Then A1 is slashed by B2, flag down. A1 passes the ball out of the attack goal area, ending the flag down, and then A1 retaliates by cross checking B2, earning a 2-minute unsportsmanlike conduct penalty.
 - a. B1 serves 30 seconds, B2 serves 1 minute and A1 serves 2 minutes non-releasable for his cross check.
 - b. Shortest common penalty time between two teams is 30 seconds, so first 30 seconds are non-releasable and then B2 and A1's penalties are releasable after their first seconds.
 - c. Longest common penalty time is 1 minute, so the first minute of all penalties are non-releasable and after that A1's penalty is releasable.
 - d. B1, B2, and A1's penalties are non-releasable.

2. During the second half with a running clock, B1 has 25 seconds left in his technical foul penalty and then A1 gets a 1 minute personal foul penalty.
 - a. Both fouls are releasable.
 - b. Both fouls are simultaneous and non-releasable.
 - c. Penalty time is also running time, commensurate with the game time.
 - d. Both a and c are correct.

3. Player A1 is serving a 1-minute personal foul. Ten seconds into his penalty, player B1 gets a 30-second technical foul. Play resumes with Player B2 in possession of the ball inside his offensive box but the halftime horn sounds before any player is released. How does the second half start?
 - a. Faceoff.
 - b. Because there are players in the penalty box, B team retains possession.
 - c. Team A gains possession because their penalty time is less.
 - d. None of the above.

4. Team B strikes attackman A1 with a hit to the head and is assessed a 2-minute non-releasable foul. The ball becomes loose and seeing the flag down, attackman A1 slaps his opponent on the back of his helmet and says, "Nice hit.". Which team is awarded possession, why and where?
 - a. Since both fouls are simultaneous and Team A was in possession last, they retain possession 20 yards lateral from the goal.
 - b. Since Team A's penalty was second, they will get possession and under the simultaneous foul rule, Team B will receive possession now clearing at the same relative position on the field.
 - c. Since Team A's foul was a dead ball foul, Team B will get possession with a free clear.
 - d. Since both fouls are simultaneous and the ball was loose at the time of 2nd foul, alternating possession (AP) will be used.

5. During live play, B1 slashes A1, who in pursuing the goal, makes a comment directed at his defending opponent and says, "Watch this."
 - a. Flag down, slow whistle, A1 is awarded possession and B1 serves releasable 1-minute for slash.
 - b. Because fouls are simultaneous, flag down, slow whistle as Team A continues to pursue the goal.
 - c. Flag down for the B1's slash and flag down for A1 taunting, Team A retains possession and both fouls are non-releasable.
 - d. B1 is awarded possession because A1's foul was 2nd and kills the play.

6. B1 is assessed a 1-minute slash penalty, followed by B2 who is assessed a 2-minute non-releasable for an illegal hit to the head and then the Team B Head Coach is assessed a conduct foul.
 - a. Because there is more than one player assessed penalty time, the longest common penalty time of 1-minute is non-releasable.
 - b. The conduct foul by Team B makes all fouls non-releasable.
 - c. B1 serves 1-minute for slash, B2 serves 2-minutes non-releasable for illegal hit to the head, and in-home serves 30-seconds non-releasable for coach's conduct foul.
 - d. All fouls except B2's illegal hit to the head are releasable.

7. Before a faceoff, Team B delays the game then A1 and A2 commit a conduct fouls.
 - a. These are not simultaneous fouls, because we can follow sequence.
 - b. Team B is awarded possession.
 - c. Team A in-home serves a 30-second technical foul.
 - d. All of the above.

8. As the period comes to an end, Team B was in possession as there is a flag down against Team A for an illegal hit to the head and a 2-minute penalty is assessed. During your routine between quarter equipment inspection, the referee determines that Team B be assessed a 1-minute penalty for a deep pocket.
 - a. These are considered simultaneous fouls and Team B, with lesser penalty time, will receive possession.
 - b. Because this is a dead ball foul, Team A will now receive possession.
 - c. Flag denotes possession, so Team B will retain possession.
 - d. None of the above because these are not simultaneous fouls.

9. Team A is in possession of the ball and there is a slash foul assessed to Team B – we have a flag down. Team A is now called for illegal screen.
- Play is terminated by A1's technical and A1 will be awarded possession.
 - Since these fouls are simultaneous, both A1 and B1 serve, with the longest common penalty time of 30-seconds as non-releasable.
 - Because Team A's penalty was last, Team B now gains possession.
 - None of the above because one foul is personal and the other is technical.
10. During a loose ball, B1 pushes A1 from behind and a "play on" is called. While the ball is still live, A1 turns and slashes B1.
- Since Team A was entitled to possession, all players serve penalty time.
 - B1 serves 30-seconds, A1 serves 1-minute, and team with lesser penalty time gains possession.
 - The first 30-seconds of penalty time is non-releasable.
 - All of the above.
