**Subject**: 2022-23 MPSSAA Registration Fees

The purpose of this memo is to inform all high school sport officials with intentions of registering and certifying as a sport official for the 2022-23 academic year of fee changes to the registration and certification process. The purpose of the rate changes, which is the first fee increase in over 12 years, will support initiatives in the retention and recruitment of officials, provide additional professional development for officials, encourage officials to officiate multiple sports, and to provide an increase in rates for officiating MPSSAA post-season events to all participating state tournament officials.

#### 2022-23 MPSSAA Registration and Certification Fee Increase

- MPSSAA registration fee for an official who is registered to officiate one sport is \$40.00.
- MPSSAA registration fee for an official who is registering to officiate additional sports will be \$20.00 per sport.

The 2022-23 MPSSAA Registration and Certification fee increase will be a total of \$6.00 for the initial sport registration. This increase incurs all processing fees for the registration system (please note the MPSSAA paid over 3.00 per official in 2021-22 to incur processing fees without raising rates on officials).

The 2022-23 registration fees also brings relief and discounts to our coveted multi-sport officials. An official who certifies in additional sports will pay \$20.00 for each additional sport (Previously two sport officials would have paid \$68.00 – under the new fee discount it will be \$60.00; Previously three sport officials would have paid \$102.00 – under the new fee discount it will be \$80.00.), providing larger discounts for the more sports an official certifies in.

The 2022-23 registration fees also allows the MPSSAA to provide a \$10.00 increase across the board for all officials who are assigned to officiate state tournament contests. In addition, the MPSSAA will be looking to expand professional growth opportunities as well as recruitment and retention strategies for high school sport officials.

### **Benefits for 100% State Associations:**

- 1. **EXAMS**. Unlimited number of FREE electronic NFHS sport rules (Part I and II) and mechanics exams for officials on the NFHS testing platform. Features include:
  - Ability to customize testing features such as: number of questions, randomized question order, testing date range, adding state-specific questions, number of "takes" permitted, how/when test-taker sees results.
  - Technical support to officials on testing platform.
  - States that have developed their own testing platform or want to print and distribute the tests on their own, will be provided an electronic version of the NFHS exam.

**NOTE**: Non-100% states are charged \$.45 for each individual test-taker on the NFHS platform or \$200 for each electronic version of an NFHS exam. Total annual state value = approximately \$2000 to \$6000.

**NOTE**: Non-100% states are charged \$49.95 per sport CD ordered. Total annual state value = approximately \$1000 to \$3000.

3. **ONLINE RULE INTERPRETER'S MEETINGS**. FREE access for up to five (5) connections to each sport's online rule interpreter's meetings.

**NOTE**: Non-100% states are charged \$50 for each online connection. Total annual state value = approximately \$1500 to \$4000.
